**Subject : REGIONAL ROLL OUT OF THE LOCALIZED GUIDELINES FOR THE
SAFE SPACES ACT GUIDELINES FOR HIGHER EDUCATION SECTOR**

Relevant to the conduct of the Regional Roll Out of the Localized Guidelines of the Safe Spaces Act Guidelines for Higher Education, the undersigned requests for the regional offices' assistance in securing venue, accommodation and food services within the region. Likewise, may we request that the invitation to the said event be facilitated by regional office staff.

Expected guests are students, teaching and non-teaching personnel, and school officials of private Higher Education Institutions (HEIs), State Universities and Colleges (SUCs), and Local Universities and Colleges (LUCs). A total of 200-300 participants may be invited for this roll out. Said event is expected to last half the day only.

The CHED GAD Unit from the Central Office shall transfer funds for the expenses to be incurred based on the estimated computation sent by the region. Kindly include in the expenses the following:

- accommodation for eight personnel from the Central Office (two from OCAD, three from the GAD Unit, and three from the Technical Working Group)
- airport transfers of Central Office personnel, when applicable
- fast craft transfers of personnel, when applicable
- meals of the Central Office personnel for the duration
- supplies (kits) including reproduction costs
- tarpaulins and other collaterals
- AM snacks for 200 to 300 participants
- honorarium for guest lawyer (if no lawyer from the TWG is available)
