- 1. Pursuant to Republic Act No. 6949 series of 1990, declaring March 8 of every year as the National Women's Day, and Proclamation No. 227, series of 1988, providing for the observance of the Month of March as Women's Role in History Month, this Office will be spearheading various activities from **March 01 31, 2024**.

# REGISTRATION, MECHANICS AND CRITERIA FOR THE BEST RESEARCH ON GAD OR WOMEN EMPOWERMENT

- 1. Each HEI may submit one entry per category (1 faculty member and 1 student).
- 2. For HEIs with satellite campuses, each satellite campus is also allowed to submit one entry per category.
- 3. The Gender and Development Focal Person/ Coordinator should endorse the names of the participants. The endorsement must bear the name, **course and year level (for students only)**, age, sex, email address, and phone number of the contestant.
- 4. All entries must be uploaded in the Google Drive Link: <a href="https://bit.ly/2024NWMCResearchGAD">https://bit.ly/2024NWMCResearchGAD</a> until March 12, 2024. Each entry must be saved in pdf format. It must be uploaded in a folder together with the HEI's endorsement. The folder shall be labeled using the following format:

(HEI Acronym, Faculty/Student, Last Name, First Name) ex. (PCLU Student, dela Cruz, Jose)

- 5. The research must be unpublished, completed from January 2022 to February 2024, and may be of any type including theses/dissertations as long as they contribute to Gender and Development and/or Women Empowerment.
- 6. Entries for each category will be pre-judged according to the following criteria:

a.	ORIGINALITY and SIGNIFICANCE OF STUDY	25%
b.	INTRODUCTION AND OBJECTIVES	10%
C.	RESEARCH DESIGN AND METHODS	20%
d.	RESULTS/FINDINGS (INCLUDING TABLES, FIGURES)	25%
e.	CONCLUSION and RECOMMENDATIONS	20%

- 7. Only the top three (3) finalists per category will be chosen based on the above criteria. Prejudging scores will be converted to seventy percent (70%) of the final score.
- 8. The finalists will be notified by email and telephone (if possible) by Dr. Ricky Cera or Dr. Al Gerald Barde on or before **March 15**, **2024**.
- 9. Finalists will present their papers onsite on March 19, 2024.
- 10. The oral presentation will comprise 30% of the 100% and will be added to the pre-judging score of 70%. The criteria for the oral presentation are:

CLARITY & LOGICAL FLOW OF PRESENTATION	25%
VISUAL QUALITY OF SLIDES	20 %
STAGE PRESENCE and ORAL DELIVERY	25%
ANSWERS TO QUESTIONS	30 %

11. The research copy to be submitted must be in capsule format. Please observe the following:

Font Style: Arial

Margin: 1" all sides except left margin (1.5")

Spacing: double-spaced

Paper Size: short bond paper (8.5"X 11")

### Number of Pages:

- a. Title Page (with Title, Full Names of Author/s, Institutional Affiliation, Date Completed)- 1 page
- b. Abstract 1 page
- c. Introduction maximum of 2 pages
- d. Problem, Research Design, and Methods maximum of 4 pages
- e. Results/Findings maximum of 8 pages (tables may be used instead of text where they add clarity and conciseness.)
- f. Conclusions and Recommendations maximum of 2 pages
- g. References maximum of 2 pages
- 12. The order of presentation will be determined by drawing of lots. Oral presentations must be completed in nine (9) minutes, with six (6) minutes to answer questions. Each of the judges may ask one (1) question. A warning signal will be given at five (5) minutes.
- 13. Winners will receive cash prizes and certificates.

# REGISTRATION, MECHANICS AND CRITERIA FOR THE GAD REGIONAL QUIZ SHOW

#### Guidelines:

- 1. The coverage of the GAD Regional Quiz Show includes the following but not limited to:
  - a. republic acts, house bills, senate bills and other legal documents related to Gender and Development concepts;
  - b. articles, reports, researches and other publications relative to the history and evolution of gender and development; and,
  - c. renowned women that play significant roles in the areas of economy, politics, education, technology and history of the Philippines.
- 2. Each higher education institution (HEI) is only allowed to send **one (1) group**, composing of two (2) students to participate in the quiz show. For HEIs with multiple campuses, the institution is allowed to send one (1) group per campus.
- 3. The participants should be bona fide students enrolled in the institution for the 2<sup>nd</sup> Semester, AY 2023-2024.
- 4. The contestant will be given letter cards "A, B, C and D" for multiple choice questions and a clean coupon bond/cardboard for non-multiple choice questions. Also, the participants should write their answers clearly and legibly on the provided answer board.
- 5. There should be NO abbreviations or acronyms allowed unless instructed to do so.
- 6. Any participant who will be caught cheating will be automatically eliminated from the competition.
- 7. Questions will be read twice by the quizmaster.

### Registration and Documentary requirements:

- 1. Participants are required to register and upload the scanned copy of the following to the link <a href="https://bit.ly/2024GADRegionalQuizShow">https://bit.ly/2024GADRegionalQuizShow</a>, on or before March 15, 2024:
  - a. Copy of endorsement letter from the president or dean or any equivalent position capable of endorsing the student as the official contestant.
  - b. Copy of current student ID duly certified by the registrar or copy of the latest registration/enrollment form/certification duly certified/issued by the registrar indicating the program and year level of the student.
- 2. Only contestants with complete supporting documents will be allowed to join the competition.

#### Mechanics:

 The GAD Regional Quiz Show is comprised of three rounds: EASY, MODERATE, and ADVANCED.

- 2. Each group shall write their answers before the time allotted has lapsed. Answer boards shall be raised once the quiz master declares so. Any group who fails to comply will receive a warning and their answer may be forfeited depending on the decision of the quiz master.
- 3. If there is a tie after the three rounds, a tie-breaking question will be asked until the deadlock is broken. The quiz master reads each question twice. Tie-breaking questions shall not affect the participant's overall score. Whoever gets the correct answer first shall be declared as the winner.
- 4. Cash prizes and certificates will be given to the top three winners.
- 5. Certificates for the top three coaches will also be awarded.



# REGISTRATION, MECHANICS AND CRITERIA FOR THE SEARCH FOR THE BEST GAD CORNER

#### **CONTEST OBJECTIVES:**

The competition aims to promote and develop gender responsiveness by mainstreaming gender activities and concepts, re-intensify awareness on GAD activities by creating a corner or designating a focal space to serve as venue for sharing of information about gender and development programs, projects and activities of the higher education institution.

#### **MECHANICS**

- 1. The institution shall devote a space in the school campus to serve as GAD Corner. The space must be accessible to all stakeholders.
- 2. The GAD Corner may be decorated using purple as dominant color. It must convey messages of Gender Mainstreaming, Women Empowerment, and Gender Equality. The GAD Corner shall be a permanent part of the institution's building layout, and to be updated from time to time.
- 3. Interested higher education institutions (HEIs) are only allowed to send **one (1) entry**. For HEIs with multiple campuses, the institution is allowed to send one (1) entry per campus.
- 4. The institution shall conduct a virtual tour on their GAD Corner and document the same through a video presentation.
- 5. The video shall have a minimum of one (1) minute and a maximum of three (3) minutes duration.
- 6. Interested HEIs are required to register and upload their GAD Corner Video Presentation to the link https://bit.ly/2024BestGADCorner, on or before March 15, 2024.
- 7. The organizers will upload the entries on the CHED Region 1 Facebook page. CHEDRO1 shall have the intellectual property rights and exclusive use of the videos submitted. CHEDRO1 shall have the sole right to use, produce or reproduce the submitted videos with proper credit/citation.
- 8. There will be 3 winning entries that will receive cash prizes and certificates.
- 9. The criteria for judging are as follows:

Content50%Quality of Production30%Creativity20%Total100%
