SUBJECT	:	CALL FOR NOMINATIONS FOR NEW MEMBERS OF THE CHED REGION 1 QUALITY ASSESSMENT TEAM (RQAT)

- Pursuant to CHED Administrative Order No. 03 s. 2014, otherwise known as "Revised Guidelines in the Operation of Regional Quality Assessment Teams (RQAT)", this Office is now accepting nominations for the selection of new RQAT members in various academic and industry disciplines.
- 2. RQAT members are pool of experts assisting CHED Regional Offices to evaluate and validate the capability of higher education institutions to offer programs based on the Policies, Standards, and Guidelines issued by CHED.
- 3. The members of the RQAT shall preferably come from:
  - Higher Education Institutions (HEIs) with autonomous/deregulated status, or with COE/COD programs, or with programs accredited by recognized accrediting bodies;
  - Relevant industry/sector;
  - Relevant accredited/recognized professional associations/organizations; or
  - Appropriate government/non-governmental agencies
- 4. The qualifications of RQAT members are as follows:
  - A Filipino citizen and of good moral character;
  - Known to have the integrity and credibility in the practice of his/her profession;
  - Must be a graduate from reputable HEI/s;
  - At least a master's degree holder in his/her field of specialization or with extensive industry experience or a successful practitioner, if to be involved in the evaluation of undergraduate programs;
  - At least a doctorate degree holder in in his/her field of specialization, if to be involved in the evaluation of graduate programs;
  - Must have a valid license from the Professional Regulation Commission, if applicable; and
  - Must be an active member of professional organization/s, if applicable.
- 5. President/Heads of HEIs are encouraged to submit the names and curriculum vitae of their nominees on or before May 10, 2024 to this Office for review and vetting. Template of the nomination form is attached for your reference.
- 6. For the information, guidance, and compliance of all concerned.
